Baker Clause policy statement

As part of our commitment to informing our pupils of the full range of learning and training pathways on offer to them, we will consider requests from approved training, apprenticeship and vocational education providers to speak to pupils.

This policy statement sets out the school's arrangements for managing the access of providers to pupils at the school for the purposes of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997.

Pupil entitlement

Pupils in Years 8-11 are entitled:

- To find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point.
- To hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options evenings, assemblies, group discussions and taster events.
- To understand how to make applications for the full range of academic and technical courses.

If you are a provider for pupils, you will have opportunities to access pupils through assemblies, consultation evening, careers fairs and additional drop-down days which are planned each year. Providers will be asked to provide the following information:

Providers are providing the following set of prescribed information:

- Information about the provider and the approved technical education qualifications or apprenticeships that the provider offers.
- Information about the careers to which those technical education qualifications or apprenticeships might lead.
- A description of what learning or training with the provider is like.

- Responses to questions from the students about the provider or technical education qualifications and apprenticeships.

Please speak to Janet Sharkey, Head of Careers, to identify the most suitable opportunity for you.

Safeguarding

The school policy on safeguarding sets out the school's approach to allowing providers into school as visitors to talk to our pupils. Requests from providers will be supported if possible but will not be granted in the following circumstances:

- · Access cannot be fitted within the careers education programme;
- Repeated access is requested;
- · Access will compromise another aspect of careers education.

Premises and facilities

The school will endeavour to make the main hall, classrooms or private meeting rooms available for discussions between the provider and pupils, as appropriate to the activity. The school will also make available audio-visual equipment and other specialist equipment to support provider presentations. This will all be discussed and agreed in advance of the visit with the Head of Careers or a member of the careers team.

Providers are welcome to leave a copy of their prospectus or other relevant course literature with the school's Careers Resource Centre.
